Dear Sir/Madam:

Our firm represents Virtual Realms Ltd., and we are authorized to issue this takedown demand. Data belonging to Virtual Realms, including copyrighted data - specifically, source code for its game Warhammer Odyssey (“Data”) - has been unlawfully posted to the RaGEZONE forum website. The posting may be found here:

Virtual Realms has not and does not authorize this posting of the Data, or any posting of any of its data, on RaGEZONE.

Virtual Realms requests and demands that access to the Data be immediately disabled and taken down. Our client requests and demands that RaGEZONE remove the Data from its platform, and that RaGEZONE prohibit and ban from its forum the user that posted the Virtual Realms’ Data.

In order to permit Virtual Realms to protect its rights, including its intellectual property rights, our client further requests and demands that RaGEZONE provide account details and all other data relating to the account holder(s), account user(s), and account activity to the appropriate legal authorities, including the Thai and foreign law enforcement agencies.

We ask that the takedown and removal of the Data be completed within three (3) business days of the data of this letter, and that RaGEZONE promptly confirm compliance with
